2021 E/M UPDATE

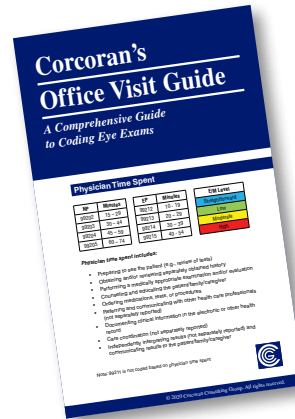
